

TASO-San Antonio Football Chapter Hall of Honor Membership Policy

(formerly known as Honorary Life Membership)

The purpose of having a Hall of Honor Membership Policy is to select individuals who have distinguished themselves through outstanding service to the sport of football through officiating.

1. The following qualifications shall be required for consideration as a *Hall of Honor Member*:
 - A. Retired from the TASO-San Antonio Football Chapter (aka, SFOA), hereby referred to as “*the chapter*”,
 - B. Member in good standing at the time of retirement;
 - C. Member of “*the chapter*” for at least ten years and a member of Division I or II;
 - D. Met at least one, and preferably more, of the following criteria:
 1. Served as an Officer or Division Representative of “*the chapter*”,
 2. Served as District Representative to the TASO—Football (aka, SFOA);
 3. Made significant contributions to “*the chapter*”;
 4. Made significant community achievements that reflected positively upon “*the chapter*”.
 - E. A person otherwise qualified for Hall of Honor Membership must have his name submitted for consideration within ten years of his/her retirement

2. Selection of Hall of Honor Members:
 - A. The Board of Directors may appoint a committee for the purpose of recommending persons for honorary life membership. Any member in good standing may recommend to the Hall of Honor Membership Committee candidates for consideration by the committee.
 - B. There is no requirement that “*the chapter*” select Hall of Honor members on an annual basis. Selections should only be made when there exists distinguished and meritorious candidates. The Hall of Honor Membership Committee shall forward their recommendations, if any, of candidates for Hall of Honor membership to the Board of Directors for consideration on or prior to October 15th.
 - C. The Board of Directors shall submit to the general membership the name(s) of individual(s) approved by the Board of Directors for Hall of Honor membership. **Approval by a simple majority of the general membership present and voting shall determine Hall of Honor Membership.**
